

## **Information on Biomass Feedstock Producers**

In December 2020, as part of the Request for Qualification for the (“RFQ”) for the Second Tranche Procurement Programme, ESERA conducted a workshop for biomass feedstock producers in Eswatini to provide information and clarifications regarding ESERA’s approach with respect to the anticipated feedstock supply arrangements for the proposed biomass power plants and to get feedback from the biomass sector. Thereafter, ESERA launched a Biomass Feedstock Questionnaire to request parties who were interested in potentially becoming biomass feedstock suppliers in the Second Tranche Procurement Programme to submit details about their available biomass feedstock.

ESERA prepared a summary of the information provided by respondents pursuant to the Biomass Feedstock Questionnaire to assist the Applicants to identify biomass feedstock suppliers for the Second Tranche Procurement Programme. The contact details of the biomass feedstock producers, the biomass feedstock type and the expected annual volumes are provided in Table 1 below.

The information is being shared as received by ESERA and is for the Applicant’s information and assistance only. Inclusion on this list does not constitute any form of endorsement by ESERA, nor does it constitute any form of shortlisting, pre-qualification or any other form of selection for purposes of procurement for new generation capacity. Furthermore none of ESERA or the Government, nor any of their respective officers, employees, servants, agents or advisors makes any representations in respect of any of the listed biomass feedstock producers and the Applicants are under no obligation to use any of these biomass feedstock producers. Applicants are equally entitled to partner with biomass feedstock producers, whether listed in Table 1 or not.
